

BOARDING CONTRACT for Bear Creek Animal Clinic

Bear Creek Animal Clinic agrees to exercise reasonable care to ensure the safety of the pet listed above; to keep clinic premises sanitary and properly enclosed; to ensure all pets are properly and regularly fed, and housed in clean, safe quarters; and to keep pet on premises unless owner gives consent. BCAC reserves the right to use its own best judgement in how to best provide care for this pet while boarding.

HEALTH: For the welfare of all pets in our facility, the following requirements must meet and abided by:

- **IMMUNIZATIONS:** All pets must be up-to-date on vaccines according to BCAC requirements. Any vaccines not up-to-date will be administered at time of drop-off, at owner's expense.
- **PARASITES:** All pets must be free of parasites, including fleas, ticks, and intestinal worms. If the pet is found to have any parasites they will be treated, at owner's expense.
- **MEDICATION:** If the pet is currently on medications, staff must be informed of all instructions and medications must be clearly labeled. There may be a charge for administering medications based on frequency and difficulty.
- **BEHAVIOR:** BCAC reserves the right to use tranquilizers if deemed necessary for the health and safety of the pet or for the safety of others.

PERSONAL ITEMS: _____
BCAC is not responsible for loss or damage to any personal item(s) left with pet.

TREATMENT AUTHORIZATION: If the pet becomes seriously ill, BCAC will make every reasonable effort to notify the owner. If owner does not inform clinic immediately regarding measures to be taken or if the state of animal's health reasonably demands quick action, clinic will treat pet as it deems necessary.

EMERGENCY CONTACT: _____

For minor illnesses I authorize up to (**CIRCLE ONE: \$100 \$250 ANY**) costs in medical care.

ABANDONMENT: Pets are considered abandoned if not picked up within 10 days of arranged date. Proper authorities will be contacted and clinic may, at its discretion, dispose of said animal in any way deemed fit. Abandonment does not release owner from obligation to pay the bill or legal fees in full.

ACKNOWLEDGEMENTS: BCAC is staffed Monday through Friday 7:00am - 6:00pm & Saturday 8:00am - 12:00pm. On weekends and holidays staff will attend to boarded pets twice daily for as long as it takes to care for them. Outside of the times listed, there is no staff member on clinic grounds. The clinic is not equipped with a fire protection sprinkler system.

By signing this contract, I certify that I am the owner, or authorized agent, of the above pet and agree to the terms of boarding my pet at Bear Creek Animal Clinic. I agree to pay for all services provided at time of pick up. To the best of my knowledge, the pet has not been exposed to rabies, distemper, or any other contagious illness in the last 30 days.
